## Description of Art Installations

*Sarah Birmingham Drummond serves as Founding Dean of Andover Newton Seminary at Yale Divinity School. She has been part of Andover Newton since 2005. She serves as the seminary’s lead administrator and chief academic officer and is part of the senior leadership team at Yale Divinity School. She also teaches and writes about leadership*



and serves as combination advisor/minister/mentor to students engaged in graduate theological education. Sarah earned her Ph.D in Urban Education at UW– Milwaukee with a specialization in administrative leadership. During those same years, she served as Campus Minister and Executive Director of University Christian Ministries, an ecumenical outreach at UWM.

She is an ordained minister in the UCC. Sarah earned her Master of Divinity from Harvard Divinity School. Her Bachelor of Arts degree comes from Yale, where she majored in Ethics, Politics, and Economics. Sarah has written five books on ministerial leadership and dozens of articles on the same. Her most recent books are *Sharing Leadership: a UCC Way of Being In-Community and Intentional Leadership In-Between Times*, published by the Pilgrim Press in 2021 and 2022 respectively. Sarah blogs weekly on Medium and her current series is entitled “Ministry Demystified.” In that series, she uses a humorous and hopeful approach as she addresses the pressures and possibilities of leadership.

# 2023 Annual Meeting Procedural Guide

1. Voting membership consists of ordained ministers of the Conference and two (2) lay delegates from each local church, plus one (1) for each additional 500 members or major fraction thereof, beyond the first 500, and also such lay persons, not delegates from their local church, who are at the time serving as an officer of the Conference, a member of the Board of Directors, or as Chairperson of a Commission, Council, or Standing Committee designated in this connection; and all commissioned or licensed workers or ministers engaged in full-time church service, and all full-time Directors of Christian Education who have been certified by the UCC through its appropriate agency and by an Association of the Conference.
2. A quorum for a Conference meeting shall consist of Representatives, either ordained ministers or lay delegates, from at least one-third of the constituent churches of the Conference, provided that such ministers and local churches have full standing in the United Church of Christ.
3. A simple majority is required for transaction of all business unless otherwise provided for in the Constitution. One such exception which requires a two-thirds vote is an overture to General Synod (Constitution, Article VII, D).
4. Only registered voting delegates situated within the bar of the house may vote. The bar of the house this year includes the entire seating area in Pillsbury Hall.
5. All motions regarding budgetary items or financial commitments beyond the budget must be referred first to the Business Committee.
6. Subject to waiver by an affirmative vote of at least two-thirds of those present and entitled to vote, no resolution or other action, except elections, matters of procedures and amenities shall be voted upon unless a recommendation that the same be presented for vote shall have been adopted by the Business Committee.
7. Discussion on any motion shall be limited to five (5) consecutive minutes per presenter and two (2) minutes to each of the other speakers. A delegate who has spoken shall not speak a second time on the same question as long as any delegate who has not spoken on that question desires to speak. Please always identify yourself and your church.
8. All major motions and amendments shall be placed in writing by the mover and immediately delivered to the presiding Moderator. Please see an usher for a sheet on which you can print major motions. Please print and include your name, church name, and church location.
9. Friendly motions and amendments to amendments are not permitted.
10. Nominations may be made from the floor for any office or posted at the time of the election providing the nominee has consented to serve if elected.
11. The Secretary's Minutes will not be read and approved at the opening of each succeeding session, but will be read and approved by a Committee of three persons authorized by the Board of Directors.
12. Procedures shall follow Robert's Rules of Order, newly revised, except as modified by this Procedural Guide.
13. According to our polity, the actions taken speak only for those assembled here, but should be held in the highest regard by every local church (Constitution, Article V).

However, once an undebatable motion has been made and seconded, the Chair will normally not recognize other speakers until the vote has been taken.







## 2024 Proposed Budget

On the income side, OCWM Basic Support continues to provide most of the funding for the conference. We project that increased income from our investments, growth in individual giving, and common services revenue (fees paid by four Associations and the Wisconsin Foundation for staffing) will offset anticipated declines in Basic Support.

On the expense side, we anticipate modest changes in staff compensation after having made some significant adjustments to salaries to reflect inflation in 2023. The move of the Wisconsin Conference office from the Trost Center to the Daycholah Center provided slight savings in basic operations. In the programs section, note that the Damascus Project support now appears in this category (past support was in the staff category). Our support declines as the Leadership Forward Campaign grows the Damascus Project Endowment. Additionally, while Wider Church Ministries remains 41.7% of our OCWM Basic Support, we continued to shift funds into the “Grants from Partners” to allow for more strategic engagement with our partner organizations.

The slight deficit projected for 2023 and 2024 will be funded with past surpluses, such as in 2022.

# Wisconsin Foundation UCC Annual Report



The Wisconsin Conference UCC founded the Wisconsin Foundation UCC in 2019 to strengthen the financial and fundraising capacity of congregations and the Conference. More than 20 congregations, organizations or initiatives hold \$3.5 million in the foundation; an additional \$10.5 million belongs to the Conference, associations and foundation itself. (Total assets were \$14 million at the end of 2022.) By working together in the foundation, we strengthen the United Church of Christ in Wisconsin.

## Helping to Raise the Next Dollar

The Wisconsin Foundation UCC helps its partner organizations raise new contributions for their endowments. This help ranges from facilitating gifts of stock and consulting on gift opportunities to guidance on endowment-building campaigns. Over the past three years, the foundation helped raise an average of \$300,000 a year in new contributions. Although the amounts raised by any one congregation vary widely, the ability to help churches occurs because we cooperate together in the foundation.

## Assisting as Churches Adapt

The council of Trinity UCC of Portage, below left, decided to sell their church building and relocate to rented space in the community. The move freed up financial resources for ministry. Because of the Wisconsin Foundation, Trinity could offer seller financing to the new congregation that wanted to purchase the building. The foundation tracks mortgage payments for Trinity and manages their invested funds so the council can concentrate on ministry in their community. “I was very happy with


all Andrew’s work in making this transition happen,” said council President Joy Morse, referring to the Rev. Andrew Warner, director of development for the Wisconsin Conference and president of the foundation. “It was not an easy thing to do but we were all in agreement that it was time because of our declining membership. Our new location has been so accommodating and we actually have a new person coming on Sundays.”



Pastor Kay Hallanger, reflecting on what the congregation learned about generosity through the process, said: “Andrew gave us suggestions on being generous with what was in the building. As a result, we gifted our local museum as well as two state museums with church records of great historical value, some going back

to the early 20th century and in German. Our sister church in Endeavor received furniture and many other items, which they are putting to good use. We gifted Bibles and hymnals to a residential facility and another UCC church. We plan to gift a significant portion of the proceeds from the sale of our building to local community groups which could benefit. As we continue through this process, we have come to realize generosity comes in many forms. The sale of our building will benefit others in ways we had not foreseen but certainly have come to appreciate and be forever grateful.”

**Diversified Investments Include Camp**

The Investment Committee of the Wisconsin Foundation UCC works with our investment manager to ensure a well-diversified investment pool. In general, we aim to invest 65 percent of our funds in equity and 35 into into fixed-income assets (primarily bonds), but the investment manager can vary this by up to 10 percent in either direction based on market conditions.

Unique to the Wisconsin Foundation UCC as an investment option, our fixed income assets include a significant loan to United Church Camps, Inc. The loan reduced the interest rate paid by the camps but exceeded the 5-year average return on bonds for the foundation—a win-win.

The Rev. Jim Schlieff, executive director of UCCI, spoke to the impact of this loan on outdoor ministry. “The low-interest loan meant UCCI could restructure and reposition the organization for continued operation so that we can provide outdoor ministry opportunities to the local congregations of the Wisconsin Conference UCC and community partners,” he said. “This has been a lifeline allowing UCCI to continue operation.”

### **Investing Together Benefits Every Church**

As more and more congregations join the foundation, the fees everyone pays continue to go down. The foundation began in 2020 with annual fees of 1.25 percent, but this declined every quarter as we grew. At the end of 2022, the investment management and administrative fee was under 1 percent. As congregations continue to move into the foundation, the cost for quality investment and fundraising support will continue to decline.

### **Generating Resources for Ministry**

The past year proved to be a challenging investment environment as world events and concerns about inflation affected equity and bond performance. The investment manager for the foundation reduced our exposure by holding some funds in cash or cash equivalents. Overall, our investments outperformed the market as a whole.

### **Investing for Good**

The Wisconsin Foundation UCC practices faith-informed investing, meaning we seek out opportunities to make investments or use our shareholder votes to encourage corporate action aligned with our UCC values. The foundation works with an interfaith coalition of shareholders to press companies to change their internal policies and practices. On climate change, current shareholder activism involves a push for Bank of America, Citigroup, Goldman Sachs, JPMorgan Chase, Morgan Stanley and Wells Fargo to phase out the financing of new fossil fuel exploration. This is combined with bond investments in sustainable energy production. Together, these actions are part of the reason global investment in clean energy matched fossil fuel investments for the first time in 2022.

# **A Resolution Declaring the Wisconsin Conference a WISE Conference for Mental Health**

**(WISE: Welcoming, Inclusive, Supportive and Engaged)**

Delegates at the 2022 Wisconsin Conference United Church of Christ Annual Meeting voted to enter into a year of study and reflection on mental health and how to become a WISE Conference for Mental Health. If at least 30% of the congregations in the Wisconsin Conference UCC report having engaged this issue, a Resolution of Witness “Declaring the Wisconsin Conference a WISE Conference for Mental Health” would be voted on at the 2023 Annual Meeting of the Wisconsin Conference United Church of Christ.

Since June 2022, many Wisconsin Conference UCC congregations have engaged in study and discussion of this issue, with a significant number of congregations beginning the process of becoming WISE Congregations for Mental Health. We expect to pass the 30% threshold and the Board of Directors has endorsed bringing the resolution on “Declaring the Wisconsin Conference a WISE Conference for Mental Health” to the floor of the 2023 Annual Meeting for a vote.

## **A Resolution Declaring the Wisconsin Conference a WISE Conference for Mental Health**

*Presented to the 2022 Annual Meeting by the Board of Directors of the Wisconsin Conference of the United Church of Christ and the WCUCC WISE Team.*

### **Summary**

God's call to wholeness includes our physical and mental health. Every human has a brain and a body. Physical and mental health are, therefore, a reality of life for every person. Normalizing the importance of taking care of our physical AND mental health will help destigmatize neurodiversity (embracing the differences in brain function and behavioral traits, understanding diversity is a natural element of the human population), and challenges to our mental health (including, but not limited to, depression, anxiety, substance-related and addictive disorders) and the stigma and attitudes directed at those suffering these challenges. Creating a more welcoming community where people feel safe to address these issues will encourage those struggling to seek out needed treatment or access community support for their mental health.

While dominant media narratives and socio-political discourse would depict individuals with mental illnesses as dangerous threats to public or personal safety, in reality, statistics indicate those with a mental illness are up to ten times more likely to be the victims of violence than the perpetrators of that violence. This social stigma and resulting community isolation contribute to:

- lower rates of employment
- higher rates of homelessness and incarceration
- social policies leading to the lack of adequate and affordable mental health services

Too often, this stigma extends into the church, one place where every child of God should find support and be nurtured in their spiritual, mental, emotional and physical needs. All persons who enter our doors should feel safe and welcomed in the totality of their being. Yet, in ways both interpersonal and systemic, Christians have participated in the stigmatization and exclusion of individuals experiencing mental health challenges.

In recent years, the United Church of Christ Mental Health Network has made a concerted effort to support local churches in addressing mental health stigma through its Welcoming, Inclusive, Supportive and Engaged (WISE) initiative. The objective of WISE is to encourage UCC congregations to become more welcoming of those with

mental health challenges, to expand church and community inclusion of those who are living with mental health challenges, to be supportive of all who are affected by mental health challenges, and to engage in ways to live out a commitment to be WISE about mental health.

It is in this spirit of unconditional love and radical welcome this resolution is offered.

### **Biblical, Theological and Historical Grounding**

---

*“You shall love the Lord your God with all your heart, and with all your soul, and with all your mind, and with all your strength.” (Mark 12:30, NRSV)*

From the early historic roots of the United Church of Christ and carrying through to our present-day church bodies, it is part of our denominational identity and theology to contemplate and practice our love of God by loving our neighbors and ourselves, in body, heart, soul, and mind, in practical and life-giving ways.

We proclaim as central to the faith life of our conference this commandment Jesus offers in the Gospel according to Mark. In practice, this commandment calls the Wisconsin Conference UCC (WCUCC) to understand challenges to mental wellness as a natural part of the human experience and, through our education, programming missions and ministries, to honor the inherent wholeness of all individuals, recognizing that mental health is part of being embodied souls.

*“I give you a new commandment, that you love one another. Just as I have loved you, you also should love one another. By this everyone will know that you are my disciples, if you have love for one another.” (John 13:34-35, NRSV)*

The church united in Christ is called to be a community which breaks through fear and isolation offering love, hope, care and healing through providing compassion, community, and support. In the ways the church has hurt one another by its use of holy scripture to discriminate against mental illness, used prayer as a weapon against those seeking treatment for mental dis-ease, and ‘demon-ized’ those experiencing mental health challenges, we own the trauma and violence we have caused.

We proclaim as central to the faith life of our conference this commandment Jesus offers in the Gospel according to John. In practice, this commandment calls the WCUCC to walk alongside local ministries and members engaged in efforts to reduce stigma and enhance inclusion in their communities, provide communities of support and education for those with mental health challenges and offer tangible support through

local and conference-wide efforts.

In adopting this resolution we join the wider United Church of Christ, who in 1995, passed a resolution proclaiming justice for those with serious mental illness; who in 2015, passed a resolution encouraging congregations to become WISE; and in 2019, voted to recognize those with mental health challenges as an historically under-represented group. With these historical foundations and the work begun by the Mental Health Network of the United Church of Christ, the WCUCC will stand, historically, in a line of justice advocacy around mental health.

### **The Text of the Resolution**

WHEREAS, all people have bodies and brains and therefore have physical and mental health; and

WHEREAS, God calls all people to wholeness, which occurs through physical, spiritual, emotional and mental health, and with this understanding, God calls all people to recognize the diversity of issues related to mental health as being a natural element of the human existence; and

WHEREAS, 1 in 4 people experience some form of mental health challenge; and

WHEREAS, continued stigma, discrimination, pain, and silence occurs in society and within our churches against individuals with mental health challenges; and

WHEREAS, Wisconsin has a suicide rate of 14.5 per 100,000, above the national average of 13.5, according to 2020 data from the Centers for Disease Control; and

WHEREAS, Wisconsin consistently ranked poorly on access to mental health care, as well as, overall mental health outcomes in annual reports published by Mental Health America; and

WHEREAS, marginalized populations, particularly persons in jails/prisons, persons experiencing homelessness, persons lacking health insurance coverage, and Black, Indigenous, and People of Color (BIPOC) communities, experience systemic barriers to adequate mental health services; and

WHEREAS, the General Synod of the United Church of Christ has on three separate occasions adopted resolutions supporting the increased inclusion of individuals with mental health challenges in the fullness of the life of the church; and

WHEREAS, the Florida, Northern California Nevada, and Indiana-Kentucky Conferences have adopted WISE covenants at the Conference level; and

WHEREAS, the Wisconsin Conference recognizes the need for increased inclusion of those with mental health challenges and their communities of support in the full life of the Conference; and

WHEREAS, we recognize the communities of support for people with mental health challenges often do not have their own emotional, mental, spiritual, and physical needs met in local ministry settings; and

WHEREAS, we recognize the need to support the well-being and mental health of all, including our authorized ministers;

THEREFORE, BE IT RESOLVED, we the Wisconsin Conference (WCUCC) of the United Church of Christ, being committed to the work of justice and inclusion for all people as image-bearers of the divine, designate ourselves as a WISE Conference for Mental Health (in the community and the wider world).

BE IT FURTHER RESOLVED, the WCUCC convene a WISE Team to develop a strategic plan for implementing WISE at the conference level, including consideration of possible education and training needs, financial support, personnel, and opportunities for collaboration with existing community resources.

BE IT FURTHER RESOLVED, the WCUCC through the WISE Team, the Conference Staff and the Board of Directors, identify and pursue opportunities to be in shared mission, ministry, fellowship and advocacy with other faith and community organizations, including, but not limited to, the United Church of Christ Mental Health Network, the United Church of Christ Disabilities Ministries, and the Council for Health and Human Service Ministries.

BE IT FURTHER RESOLVED, we encourage associations and local ministry settings to develop and adopt covenants to be WISE for Mental Health, and to work to understand the needs and experiences of those living with mental health challenges and their communities of support within their local and regional settings.

BE IT FURTHER RESOLVED, we encourage local ministry settings to work to eradicate stigma around mental health challenges and neurodiversity, and to offer support to all persons affected by mental health challenges, including advocating for access to adequate treatment options for all persons but especially for persons in jails/prisons, persons experiencing homelessness, persons lacking health insurance coverage and BIPOC communities.

BE IT FURTHER RESOLVED, we encourage associations, local church ministry settings and related organizations to offer support to the family and friends of those who struggle with mental health challenges.

BE IT FINALLY RESOLVED, we encourage congregations to offer regular feedback to the WCUCC WISE Team as it works to implement WISE in the conference setting.

### **FUNDING**

The funding for the implementation of the Resolution will be made in accordance with the overall mandates of the Board of Directors as funds are available.

### **IMPLEMENTATION**

The WISE Team in consultation with the Conference Staff and Board of Directors will design a strategic plan outlining Conference priorities and new opportunities for mission and ministry to be presented to the Board of Directors of the WCUCC prior to the 2024 Annual Meeting.



## 2023 Scholarship Award Winners

### **Myrtle I. Baker Scholarship Award: Bridget Hill**

The Myrtle I. Baker scholarship was established in 1982 in honor of the Rev. Myrtle I. Baker, who in 1933 was the first ordained woman to serve congregations in the Wisconsin Conference. She served as minister of First Congregational UCC in Boscobel and the Congregational UCC at Steuben, from 1955 until her retirement in 1977. The scholarship was presented to the Wisconsin Conference by Florence M. Bohlman, a lay leader of the church at Boscobel. The scholarship is presented annually to a member in discernment who exhibits the character, love for the church and the pastoral qualities that marked the life and ministry of Myrtle I. Baker.

Bridget is the pastor of St. John's UCC, Random Lake, and New Horizon UCC, Kewaskum. She is currently a full-time seminary student at Lexington Theological Seminary and will be seeking ordination in the next couple of years. Bridget also serves as the Chaplain to the Silver Creek Fire Department. Bridget is a mother of two young adults, Toby and Anna, as well as her dog Harlan. Previously, Bridget worked in Kenya, Africa and utilized training and connections she gained through the UCC's Global Ministries resources.



### **Carl H. Zeyher Award: Jim Langreder**

The Carl H. Zeyher Award scholarship was established by the late Helen Zeyher and her family in memory of husband and father, the Rev. Carl H. Zeyher, who was ordained by the Evangelical Synod of North America at New Braunfels, Texas, in 1925 and served faithfully in congregations of the Synod, the Evangelical and Reformed Church, and the United Church of Christ, in Texas, Minnesota, Virginia, Connecticut, and Wisconsin until his retirement. ### **First Congregational Church-McDowell Scholarship: Michael Whiteley**

The First Congregational Church-McDowell Scholarship was established in 1988 by Florence and Vilas Bohlman and First Congregational UCC, Boscobel, in memory of Mrs. Bohlman's parents, Ross and Vere McDowell. The scholarship is presented annually to a seminarian and member in discernment of one of the four Associations whose devotion to the church and commitment to parish ministry offer exceptional promise for service to the Word in congregational life.

**Rev. Dorothy Heckner Mendonca**, passed away on August 28, 2022. Dorothy was one of the very first ordained women to serve the Moravian Church in Sturgeon Bay. One of her passions was Christian Education. She served as interim pastor at many United Church of Christ parishes throughout the state. In 1997, Dorothy became pastor at First Congregational United Church of Christ in Redgranite where she remained until 2014. While there, she dedicated a lot of time working for restorative justice in the prison system. Dorothy also enjoyed serving on committees for the Wisconsin Conference of the United Church of Christ. Dorothy believed in equity. She was a good listener who had relevant things to say. She was extremely independent. She was a pioneer for women clergy and women in general. She taught her daughter and grandchildren that they could do anything they set their minds to doing.

**Dorothy Mohr**, wife of the late Rev. George and mother of Rev. James Mohr, passed away on September 20, 2022. Dorothy was 102 years young. Dorothy's husband was pastor of St. John's United Church of Christ in Waukegan, Illinois for seven years; Peace UCC in St. Paul, Minnesota for seven years; and Zion UCC in Sheboygan for 25 years from 1958-1983. After his death, she lived for 35 years in her beloved condo at Cross Creek on Sheboygan's south side. Her grandchildren received many of her knit clothing items.

**Howard Dale "Howie" Gloff**, age 63, husband of Rev. Kathleen Gloff, passed from Earthly Life to Eternal Life on Wednesday September 28, 2022, at Aurora Medical Center in Kenosha, Wisconsin. He had lived with cancer since 2015. Rev. Kathleen Gloff is pastor at Somers Community United Church of Christ in Somers, Wisconsin. Howie took to being a pastor's spouse and living in a parsonage the best that he could. While in Chilton, Howie worked briefly for Kroger (Pick N Save) and then for Walmart. He promised that Kathy's work would take priority, and in 2011 they relocated to Kenosha, Wisconsin so that Kathy could become the pastor at Somers United Church of Christ.

# **Conflict Transformation Team**

## **a ministry of the Wisconsin Conference of the United Church of Christ**

As a ministry of The Wisconsin Conference of the United Church of Christ whose mission is to equip, resource and support our local churches:

- Our services are engaged through the Associate Conference Ministers, who are kept apprised of our work with the congregation.
- The Wisconsin Conference and its Associations support the training and administration needs of this ministry.

Who We Are:

- a cohort of lay and clergy persons trained in conflict transformation practices
- trained through the Lombard Mennonite Peace Institute
- gathered by the Wisconsin Conference
- for the purpose of assisting congregations and leaders of the Wisconsin Conference to bring transformation out of conflicted situations.

What We Do:

When engaged to explore solutions for a particular congregation, we send out a team of two neutral facilitators for a 2-hour initial consultation (mileage reimbursement is the only cost for the first two hours). Based on that consultation, we put together a plan (with the congregational leadership) for further work, which may include facilitated conversations, workshops for the leadership or the entire congregation or training involving conflict transformation. Once a plan and costs are agreed upon, we schedule our work with your congregation.

Services Offered:

- Facilitated conversations between conflicted parties
- Facilitating the creation of a relational covenant
- 3-hour workshops for up to 30 people. Topics are determined during the initial consultation, but may include: core values, personality types, healthy communication skills, leading through transition, understanding conflict
- Conflict Transformation Skills for Churches (8-hour workshop), including all of the above topics.

**3 Phases of the WCC's Afghan Refugee Response**

1. recruiting, training, sending volunteers to help with Catholic Charities' Morale, Wellness, and Recreation mission at Fort McCoy for **115 days of volunteer service.**
2. working with Lutheran Social Services (LSS) to coordinate the **furnishing of five homes** for Afghan and refugee families, **supporting cosponsor congregations through their discernment and orientation, and coordinating volunteer services** to their facilities in Milwaukee;
3. **allocating \$43,500 in grants** to assist partners resettling and caring for Afghans and other refugees; leading educational forums and meetings, weekly newsletter, hosting a virtual workshop on cultural competency.

# Storm Procedures

GLCC has two storm sirens:

1. **Lightning Siren:** Set off by Lawsonia or lightning strike. Siren has a tone that rises and falls, rises and falls. Lightning is a thunder storm's worse killer. Stay indoors and away from electrical appliances when storms are overhead. If you are caught outside, stay well away from the tallest conductor of electricity. (Trees, poles, etc...)
2. **Tornado Siren:** Set off by the county in the event of a Tornado. Siren is steady, just like city tornado sirens or old air raid sirens. Take cover in the following places:
  - Children's Center: Move to Lone Tree Lodge, 1st floor hallway
  - Roger Williams Inn: Back of Staughton Hall (Pacific Southwest)/ Hallway by Snackery
  - Kern: Interior hallways and West Service hallway
  - Bauer: Interior hallways and West Service hallway
  - Lone Tree Lodge: First floor hallway
  - Boathouse: RWI storm locations
  - Campers and cabins: RWI storm locations, Conwell House basement, or camp utility/bathroom buildings if there is not enough time to move to RWI
  - Kraft Centre: Basement office suite area or hallways
  - Dining Room: Basement, Kitchen, Dish Room, or Interior hallway. For safety, keep away from equipment.
  - Robbins Student Center: CYC back hallway or RWI if time permits

In the event of severe weather, Guest Services has a list to call and notify. The Safety Department notifies campers and cabins.


A Severe Thunderstorm or Tornado Watch means that the weather is favorable for severe conditions. In the event of a Watch, keep informed by listening to the radio: **WRPN 1600AM** or **Berlin 1090AM**, and keep an eye on weather conditions. Sirens will **not** blow if a **watch** has been issued, but GLCC staff will try to notify all guests.

A Severe Thunderstorm or Tornado Warning means a storm is in the area and you need to take cover. Severe Thunderstorms contain high winds and lightning and can produce TORNADOS. The Tornado siren will blow if a Tornado Warning has been issued. The lightning siren will blow if Lawsonia is open, or if lightning strikes in the area.


These procedures and shelter areas are suggestions. Every situation is different, and common sense and good judgment need to be used when taking shelter from a storm.

# Daycholah Center Map




