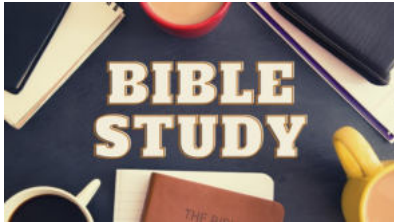

March 3, 2022

The meeting was called to order at 6:30 p.m. Members present: Larry Perronne, Julie Herrmann, Glenn Grunwald, Jacob Grunwald, Judy Steinbeck, and Louise Jetzer. Pastor Schultz and Janell were absent due to illness.

The Secretary's report was reviewed and a motion was made by Louise and seconded by Jake to approve. Motion carried.

The financial report was reviewed and a motion was made by Larry and seconded by Louise to approve. Motion carried.

## Building and Grounds:

The shower door in the parsonage will be installed within a week. The laundry cabinet will be built in the next two months by Larry. Glenn offered to help with the prep work with Jerry and Tim to get the fellowship wall repaired. The spring walk through will be completed by the building and grounds committee.

## Old Business:

We don't have any OSHA restrictions on wheelchair accommodations. We will take out a pew and put in a short pew temporarily to get an idea of how it looks and how it will work for accommodating a wheelchair. Stackable chairs were suggested to be used to not lose capacity when a wheelchair is not present. Will be further discussed.

Judy and Kathy Jurk are working on getting samples and estimates of new hymnals. We will review the samples at our next meeting.

As of March 1, 2022 Sheboygan County has lifted restrictions of covid 19 protocols so pew dividers and mask signs have been removed. Masks will continue to be available at church entrance. A motion was made to remove safety protocols by Jake and Louise seconded. Motion carried.

## New Business:

Glenn would like to see wine offered again for communion and serving bread in cubes with a tong instead of individual plastic containers. Will discuss and confirm at the next meeting.

Judy suggested we create a consistory binder with information about our church and its processes. Louise agreed to help. Larry made a motion to create a binder and Jake seconded. Motion carried.

There was a suggestion that we have an automatic defibrillator. After discussion of training needed by several people and the prep for using it and the maintenance involved, a decision was made to continue to utilize the nursing and EMT members of our congregation in case there would be such a need.

We are looking for bell ringers. This is a paid position and will be posted in the monthly newsletter.

Judy contacted the insurance company to confirm that she is bonded for \$10,000 and no additional bonding is needed.

Neumann Plumbing and Heating suggested we install a ceiling fan to help force air down so the furnace motor would not run as much. We are waiting for a quote on the ceiling fan.

Judy will contact the UCC Counsel to find out how we can support Ukraine as a church.

Our next meeting is scheduled for 4/7/22 at 6:30 p.m. Larry made a motion to adjourn and Louise seconded. Motion carried.

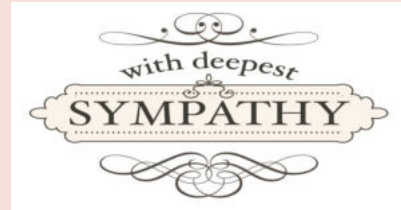

# A Workcamp in our Community Opportunity....

March 12, 2022

Fountain Park UMC

Greetings:

This summer, Fountain Park UMC will co-sponsor a Workcamp in our community. Perhaps as many as 65 resident homeowners (and their households) will benefit from the work of a projected total of 300 adult and teenage volunteers participating in the "Love Your Neighbor" Workcamp held in Sheboygan County from June 26 – July 2, 2022. The Workcamp will provide free home improvements through the Group Mission Trips program.

To allow participants to reach the areas needing repair, we will need ladders or scaffolding. This is where we could use your help!

On average, each Workcamp requires up to 75 ladders of varying heights, stepladders and extension ladders are needed. Because ladders are very difficult to transport, many volunteers who will come to Sheboygan from other cities and states will be unable to bring ladders along with them to Workcamp. This means we will need to find ladders from within our county to use for the week.
