ST. MARK'S CONSISTORY MEETING

July 6, 2023

The meeting was called to order on July 6, 2023 at 6:30 p.m. Members present were Glenn Grunwald, Judy Steinbeck, Linda Schroeder, Ben Grunwald, Julie Herrmann and Pastor Schultz. Janell Davis and Larry Perrone were absent. Pastor led us in prayer.

It was stated that some members of the congregation are concerned about animal maintenance in the parsonage and who would be responsible for payment of any repairs if they were needed. There are no current concerns at this time and Pastor Schultz and Brenda confirmed that they are very responsible with their pets and respect the parsonage and its upkeep. An occupancy agreement would state that the church pays for all normal reasonable maintenance in the parsonage and would not be responsible for additional maintenance for pets. Larry will bring a sample agreement to next month's meeting.

The financial report was read by Judy and reviewed by the consistory. Linda made a motion to accept the report and Ben seconded the motion. Motion carried.

A motion was made by Linda to accept the Secretary's report and seconded by Ben. Motion carried.

Pastor would like an expectant mother sign to be posted in the parking lot when lines are painted.

Glenn has suggested our by-laws and safe sanctuary policies be digital and scanned in as word documents to be able to edit in the future.

Judy will ask Pastor Kim Henning if he can present his Leadership Forward presentation to the congregation on July 30, 2023 after church at St. Mark's.

Pastor has suggested we have a basketball court in the parking lot to be purchased using the youth group fund. The youth are expressing an interest in having an activity like this to do together. Linda made a motion to approve pastor's request to put in a hoop and court and Ben seconded the motion. Motion carried.

The organ does need repairs or a replacement and it is difficult to find someone to repair it. We will keep it on our list for future conversation. The piano fund will be changed to the organ/piano fund so monies can be used for either the piano or the organ.

Pastor will be sending letters to the non-active members inviting them to return to church.

Communion will be changed from August 6th to August 13th. Daniel Gumm will be leading the service on August 6th and he is unable to serve communion.

Glenn has discussed the elevator inspection with Karen Mansker who called Otis Elevator and confirmed it had passed state inspection. Jerry Jetzer will find out what confirmation paperwork is needed to keep in the maintenance room. Glenn will continue to get more details on the boiler also.

The burning of the parsonage loan will take place on Sunday, August 13, 2023.

Our next meeting is scheduled for September 7, 2023 at 6:30 p.m. There will be no need for an August meeting.

Julie made a motion to adjourn and Linda seconded the motion. Motion carried.

We currently have 3 families living at Bridgeway and will welcome another new mom at the end of July who delivered a beautiful baby boy this month. We also have 2 families living at Trisha's House. Your support, prayers and engagement are greatly appreciated!
- ⇒ Come and see us at the farmers market! We are offering EBT again this year and Double Your Bucks up to \$10 for low-income neighbors. We will also hand out Senior Farmers Market Nutrition Program vouchers again, beginning in June. This year the senior vouchers have increased to \$35 and are available to people over 60 and income-restricted. See you at the Market! Every Wednesday and Saturday from 8-1 at Fountain Park, and Thursdays from 3-6pm at Riverwalk Center, 515 Mill Street, Plymouth.
- ⇒ Moment of SCIO Truth: We are struggling with keeping basic items in stock to serve our families. While we see abundant generosity over the holiday season, the summer months become long and sparse with donations. If you have capacity, please consider donating from the following list of items: toilet paper, paper towel, liquid dish soap, laundry detergent, 13-gallon garbage bags, Kleenex, floor cleaner, baby wipes, ziplock bags (quart and gallon size).
- ⇒ The Family Pathways program is thriving! As the only private supervised visitation program in the county, we are currently serving 10 families every week. We have the ability to add a few more families, so keep us in mind if you know of a family experiencing transitions between parents and children. We provide a safe and nurturing environment and offer 90-minute visits each week. Inquiries can be directed to familypathways@sheboygancountyinterfaith.org.




