Dear friends and church family,

As we wrap up our 2022 year, I want to share with you something our Wisconsin Conference offers. It's called the Damascus Project. It is a program shared between the Wisconsin and Minnesota conferences and it is designed primarily to help our lay people receive the training they need to be better equipped for their current areas of ministry or their desired areas of ministry. A lay person is someone involved, or who wants to be involved, in ministry. And they need education or training but have no desire at this time to be ordained or go to seminary.

The Damascus Project: honors diverse theological perspectives; equips the saints to build up the body of Christ; gathers spiritual seekers, lay leaders, clergy together to learn; creates brave spaces to learn and grow in faith and in leadership.

# Mission Vision Planning

Two years ago, the Joint Consistory made the commitment to organize a collaborative team tasked with developing two areas of focus and commitment and put them into meaningful words and action. For various reasons the initial organization and development of this team did not get off the ground until recently following our 2022 fall Joint Consistory meeting.

The team consists of: Jason Riesterer, Janelle Davis, Clarence Belitz, Sandy Perronne, Bruce Mansker, Deb La Duke, Dr. Patrick Schultz. Our first meeting was held November 5<sup>th</sup> from 8am – 9am.

This team will focus on a mission statement and core values providing further definition of whom we are as a church, what our vision and direction are as the local church; and a missions assessment process that evaluates pastoral ministry, church ministry, and church leadership ministry. Both are necessary as we wish to grow and sustain our ministry and mission outreach, and to reach more people with the Good News.

The mission statement and core values of the church will be developed over time utilizing resources available to us, including:

*Mission statement of the UCC* denomination (approved in 2016)

*A Vision: The Transformative UCC in Ten Years* (approved at the denominational level in 2017)

Our own pastoral search materials and profile documentation

*A Sure Foundation* (a conference level resource)

*Ministry Assessment Instrument* (Mennonite Brethren Churches in British Columbia, Annual Conference, 1995)

We will take into consideration our own experiences, traditions, reason and scripture.

This team is committed to garnering relevant information from all our church members (those attending regularly, those no longer attending but are still members, regular attendees, college students, elderly and including our shut-ins.) We are committed to open and responsible transparent communication (there is no hidden agenda) and confidentiality when appropriate. As a team we will foster an environment where we can safely discuss ideas openly and frankly, with respect for one another, and where we are prayerfully, lovingly supportive of each other.

All action items will be reviewed and approved by the Joint Consistory. All relevant ministry and/or mission work areas to give attention to – focus on – improve, change, or eliminate will be communicated to the church body and appropriately voted on when necessary.

We began with a review of our overall agenda, goals, expectations. We briefly discussed the various resources we are using (additional resources will be added/used as necessary). We began the work of identifying what we do well in ministry (strengths) and what we do not do well in ministry (weaknesses). We started a checklist of areas for the church to focus on.

Stay tuned for more information as we gather input from our congregations. Our next meeting is December 3rd, 8-9am @ St. Mark's.

### **Update on Conference purchase of Daycholah Center**

Progress continues toward the Wisconsin Conference's eventual purchase of Daycholah Center from United Church Camps Inc., an investment that will transform our Outdoor Ministries by alleviating UCCI's debt, paving the way for a long-term post-pandemic resurgence of camp and retreat programming. Work on the contract is nearly complete, with closing expected to take place by mid-December.

At the same time, the Conference staff is beginning to prepare for the eventual move from our current home base in DeForest to Daycholah on Green Lake, where we will occupy offices in the lower level of Spring Grove Lodge. Although most of our work will continue to take place remotely, and most meetings will occur virtually, we are excited about the prospect of holding in-person events in the beautiful Ley Chapel.

Lisa Hart, Associate Conference Minister for Faith Formation and Justice Ministries, hosted a training for Our Whole Lives at the Daycholah Center in August. Our Whole Lives is a comprehensive lifespan sexuality curriculum produced by the United Church of Christ and the Unitarian Universalist Association. “The church has a responsibility to help people get factual information about their bodies, to empower them to make decisions for themselves, and to learn how to show care for others,” Lisa says.

The leaders trained at the OWL retreat will become facilitators in their local congregations. Working with groups of children, youth and adults, they provide accurate, age-appropriate information that helps participants make informed and responsible decisions about their relationships, sexual health and behavior in the context of their faith.

Julia Hollister of First Congregational in Sheboygan, reflecting on her experience at the retreat. "I look forward to all the crucial conversations that will be generated through our engagement with this material that affirms body and soul."

The Daycholah Center provided leaders the gracious space they needed to learn new ways of talking about human sexuality. "Many of our participants commented on how restorative the weekend was," said Amy Johnson an OWL training and Minister for Sexuality Education and Justice with the National Setting of the UCC. "That is unusual for our trainings because they are so full in content and time-intense over a weekend. I am convinced that having these trainings at Daycholah Center significantly contributed to the restoration and healing that happened over the weekend."
