Knowing my community is a big part of effective pastoring and ministry. I have been visiting community organizations and introducing myself to: The Sheboygan County Interfaith Organization; Linda Bosman, Dir. Of Ulrich Center and Donor Relations at Lakeland University; Ride Along with Sheboygan Sherriff's officer; attended both our annual meeting in the Dells and our General Synod in Milwaukee.

I (along with Kari Langenhan and Sandy Perronne) met with Jessica Lambrecht, Asst. VP of Cooperative Ed. and Career Readiness at Lakeland University, for discussion about their intern programs. I spent one week in Chicago teaching in a doctoral preaching program. I was invited by Tim Saeger to lead/teach a class for high school sophomores at Camp Enterprise: young leaders selected by school guidance counselors and teachers throughout Sheboygan County.

From June to September, I led a weekly study group on the Gospel of John with 12-16 church members participating and from October to current, I am leading another group in the Gospel of Luke + the Thirteen Apostles with 15-20 church members participating.

This summer we held our first (with more to come!) annual Cycle Blessing event at St. Mark's.

I had 67 home and hospital visitations; 4 baptisms; 1 wedding (6-7 more are scheduled or being scheduled); 9 funerals that I officiated (1 with Pastor Ernie) and 3 more from the community that I attended.

The average amount of time for worship preparation is 15-20 hours with additional time for special services – baptisms, Thanksgiving, Christmas, Easter... Per the emphasis from the Call Team and the Call Agreement, I strive to maintain two days per week for rest and rejuvenation – I am fairly successful with this.

My family and I have been extremely blessed by our churches. You have welcomed us — and indeed embraced us. The joint leadership has done an excellent job in helping me to acclimate and learn "the UCC" way of doing things. I am privileged to be your pastor and to serve in this community. I look forward to seeing how God will use us in 2020!


New Business


