FROM PASTOR PATRICK....

On the weekend of February 13th, we enjoyed a weekend of football programming! We may not have had our home team in the game, but it was still pretty exciting. In fact, all of the playoff games leading up to Super Bowl were exciting with last-minute decisions as to who would win.

This year, the Super Bowl meant something else to me and others of our church family. This year we held a *Soup-er Bowl* Sunday. Both churches set up tables and game decorations for donations of soups and a large soup pot for financial donations.

The soups have been collected for Sheboygan County Interfaith Organization. I will coordinate our Confirmands to help deliver the soups to SCIO and get a tour of the facility and learn more about what they do there.

The financial donations are in support of a summer mission trip to Knoxville Tennessee. The arrival of the railroad in 1855 led to an economic boom, rapidly growing Knoxville into a major manufacturing center. Unfortunately, as the economy was devastated during the Great Depression in the 1930s, the manufacturing sector collapsed, and the downtown area declined. City leaders became entrenched in highly unjust political fights, all of which has sadly contributed to the highest rates of homelessness per capita in the entire country.

Despite their challenging history, Knoxville is a passionate and vibrant community, strongly committed to meeting the physical and spiritual needs of their fellow citizens, where hospitality not just a kind act, but a lifestyle.

Your missionary team will be working with other community members committed to making a difference in the lives of men, women, and children.

Currently, twelve missionaries are embarking on this adventure. Four from St. Mark's/St. James: Anna Marie Bramstedt, Olivia and Sierra Bramstedt, and Pastor Patrick Schultz. Four churches are involved: St. Mark's/St. James, Saron and Immanuel. Your continued prayers for this team are welcome (and needed!). Pray for: safe travels and zero injuries; a connection of the missionary team and the residents/community we will be serving; a coming of the Holy Spirit to wash over us; a deepening of our faith, our relationship with God, and our relationship with one another.

In financial support of the trip, we received on Soup-er Bowl Sunday, \$3,467 between both churches. We are very thankful for your generosity!


A Soup Cook-Off Fundraiser

ANNUAL MEETING MINUTES FOR ST. MARK'S

January 23,2022

The meeting was called to order by President Lori Roelse. Pastor Schultz led us in prayer. Secretary Julie Herrmann read the minutes from the 2020 Annual Meeting. Mark Jurk made a motion to accept the minutes seconded by Bruce Mansker.

Judy Steinbeck presented the 2021 income and expenses. Ron Vandoske made a motion to approve the secretary's report, Jerry Thiel seconded. Judy presented the budget for 2022. Delmar Sommer made a motion to approve the budget and Carol Weiand seconded the motion.

Pastor Schultz presented the pastors report reviewing the accomplishments and milestones with specific attention to the positive number of people using zoom and YouTube for viewing church services and how successful vacation bible school was with 20 children in attendance. Pastor has a goal to have virtual services to continue as a live stream instead of a recording.

Lori Roelse recognized the accomplishments of 2021 to include:

The repair of the bell tower was paid for entirely by members of the congregation. Vacation Bible school had not happened for several years and was a success. A group of people put a lot of work into replacing the landscaping around the parsonage, the fellowship hall lighting was improved, a TV monitor was purchased to be used for overflow seating in the fellowship hall for holiday services, Mike and Jan Marcheske implemented an assisted hearing system for members to use during church services, the youth group has started meeting twice a month for activities under the direction of Brenda Schultz and has been a great addition to the youth program, we hired a second organist, Ann Rodewald, new Christmas decorations were purchased, two Christmas eve services were well attended, a building and grounds committee was formed to include Larry Perronne, Tim Schueler and Jerry Jetzer.

New business included the need for two delegates for the Northeast Association meeting and a crop walk coordinator is needed for the Crop Walk on October 9th, 2022.

Future projects will include adding wheelchair accommodations, repairing the louvers on the bell tower, replacing the parsonage siding noting that the original parsonage loan would be paid off before replacing.

Brenda Schultz presented the Sunday school report by reviewing the activities and curriculum for 20 children K-8th grade. The Youth Group which consists of high school students have been meeting two times a month with seven attending regularly. The service project for the year was Operation Christmas Child and there will be a sign up to help with meal preparations for the youth meetings between both congregations.

The next annual meeting is scheduled for 1/22/2023. Mission Fest will be on 11/13/22, and Christmas Day service will be at St. Mark's.

Giving and contributions were reviewed and the contribution ladder was presented showing the number of contributions for 2021 and the number of members contributing.

Weather cancellations will be announced on Facebook, via email and on the church answering machine by 7 am.

Mark Jurk made a motion and Katherine Jaehnig seconded to approve the election of new consistory members, Janell Davis and Larry Perronne.

Pastor Schultz thanked Lori Roelse and Dave Call for their consistory service. Dave Call made a motion to adjourn. Glenn Grunwald seconded. Meeting adjourned at 12:15 p.m.
