Election of officers:

President-Lori Roelse, Vice President-Dave Call, Treasurer-Louise Jetzer, Secretary-Julie Herrmann

A motion was made to take \$180.00 from the Goeke Fund for Sunday school to sponsor the child from Haiti due to lack of funds from not having in-person Sunday school.

Easter Lily orders are due March 1st and will be coming from Millhome nursery.

Judy calling insurance company to find out why building and grounds insurance has increased \$611.00.

The Secretary's and Financial Secretary's reports were reviewed and accepted.

Building and Grounds:

It was questioned why so many inspections were needed for the elevator.

Discussed the possibility of forming a building and grounds committee to help maintain the landscaping and buildings. Consider a trustee to do the communicating and reporting of putting together estimates. Further discussion will be brought up at the joint consistory meeting to get thoughts from St James consistory members.

The parsonage door will not be repaired until we have warmer weather.

Old Business:

Will discuss with Kathy Jurk the possibility of her recording music to be played as a replacement for when she needs time off. Will be posting the organist position on various group music sites and to the UCC Conference.

The comments were reviewed on the ballots from the annual meeting.

New Business:

Dave made a motion and Glenn seconded to return to in-person service on Sunday 2/21/21 at 9:00 a.m. with masks and it will be announced on the virtual church service the week prior. Pastor plans to continue virtual services also. Installation of new consistory members will take place during the service.

Discussed setting up the basement for the overflow of Easter Sunday service and to include video of the service. Pastor suggested he may ask the Sunday school to do an Easter program. Communion cups will be ordered for Good Friday and Easter Sunday service. We will see how the in-person services go before deciding on the start of singing.

Dr. Julie Mavity Maddalena, the chaplain and assistant professor at Lakeland College will be leading the 3/21/21 service in pastor's absence which will be recorded and will be viewed in-person. Lori will do the welcoming and announcements and then introduce the video.

Lori suggested coming up with goals for 2021 and to think about ideas on what we can do for community outreach.

The Agenda for the joint consistory meeting was reviewed and it was decided to have it in-person on 2/15/21 at 6:00 p.m.

The next consistory meeting was scheduled for Thursday, 3/04/21 at 6:00 p.m.

JOINT CONSISTORY MEETING

2/15/21

The meeting started at 6:00 pm with introductions of members and confirming contact information of members.

Organist:

Pastor researched several churches out of the area for ideas on hourly wage for an organist position. As the meeting went on several members sent text messages to members that they knew at local churches and the standard pay was \$50 per hour for church services. There are options of recording music for services when organists cannot be there and Kathy Jurk is comfortable doing that but it is not interchangeable between St James and St Marks.

Ads for the organist position were placed on facebook and on the church website and also to Jane Anderson to place the position on the UCC conference website. Dave Call will send to the Sheboygan Sun and the Manitowoc Herald Times Reporter. Pastor will contact Lakeland College and UW Sheboygan/Green Bay campus. Pastor confirmed that he would ask Randy Sohn and Kathy Jurk to be part of the hiring process. We would be hiring on an every other weekend basis.

Pastor will get more information before we agree on an hourly wage from local clergy. It was brought up that we will not pay our new hired organist more than our current organists. Information will be gathered before our next separate consistory meeting. Lori Roelse and Clarence Belitz will discuss info and make a decision on hourly wage by the next consistory meeting.

Jobs will be posted right away but will state interviews will take place at a later time to be sure we have confirmed wages.

Format for March 21, 2021 Service:

In Pastor's absence, Rev. Dr. Julie Mavity Maddalena, the Chaplain and assistant professor at Lakeland College will be leading the service on video with the service being in-person and viewing the video. Lori will do introductions and welcoming for St Mark's service and Clarence and Deb Laduke will do introductions at St James.

Jerry Jetzer and Jacob Grunwald will help with the video equipment and projector. Dave will check on a projector he may have at home and donate it to the church. There was a suggestion to purchase a 60-inch TV for in front of church for a clearer screen and it could also be used in the basement for overflow of members on holiday services. Jerry to bring his 55-inch TV to try out and see if it's big enough to see in front of church.

Easter Overflow Plan due to Covid:

Will plan for TV in the basement and offer coffee. There will not be an additional service or sign up.

Christmas Eve service time:

Louise Jetzer made a motion and Glenn Grunwald seconded the motion to have a 4:00 pm family service and a 7 pm candlelight service held at St Mark's to accommodate times that work best for families.

Intern search:

It was discussed if we still need a youth director to oversee both St Marks and St James Sunday school programs. There were no applicants at Lakeland when we searched in the past. It would involve sharing resources between the two churches, getting materials ready for each class and offering Vacation Bible School. Pastor feels that we do not have the youth together enough outside of volleyball. We need something to bridge the connection after confirmation and would consider this a paid position. This would start in the 2021-2022 Sunday school year. Pastor will post the position in the newsletter.

Pastor's and Consistories' performance:

Clarence suggested a format for review and goal setting which they have done in the past and Dave Call made a motion and Glenn Grunwald seconded to have an informal gathering between 4 consistory members (2 from each church) and the Pastor with conversation about needs and wants and how we can support each other and review the performance of the consistories and pastor. Dave and Glenn from St. Mark's and Clarence and Deb from St James will be involved in the gathering and suggested it is good to do every year as a joint consistory and that it was positive conversation in the past.

It was also discussed to have possible Mission/Vision Teams to work on goals of our churches with our communities and our congregations.

UCC Training for pastor:

If Pastor were to change credentials it would require UCC training and psychological evaluation. There is no advantage to changing to UCC credentials so pastor is not interested.

Other items:

Pastor brought up how we are going to approach singing in church during covid and it was decided to hold off on singing until further notice and a reminder to Pastor to keep his distance before and after worship as to not promote fellowship.

Next meeting scheduled for October 18, 2021 at 6:00 pm at St James.

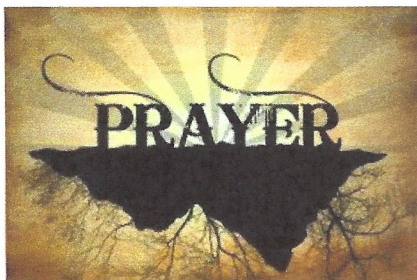


SO EXCITED AND THANKFUL!

Manitowoc - The Dementia Care Specialist (DCS) with the Aging and Disability Resource Center of the Lakeshore will be offering an educational series on the topic of Dementia. Dementia is currently the sixth leading cause of death in the United States, with Alzheimer's being the most common cause of dementia among older adults. This disease is often difficult to understand and is a sensitive topic to discuss. Caregivers of people with dementia may not always know there are resources available to help them navigate this tough disease. This series sheds light on resources available to those caring for loved ones of dementia.

The first part of the series, Dementia 101, is offered virtually on March 18th from 1-2pm and features information on the basics of Dementia. We will discuss the differences between what is considered "normal aging cognitive decline" and more medically serious diseases that cause Dementia. We will also explain why we use the terms "Dementia" and "Alzheimer's" interchangeably.

The second part of the series, Dementia 201, will be offered virtually on April 6th from 1-2pm. This educational program will be more intermediate in content.
