

ST. JAMES CONSISTORY MEETING

October 12, 2020 - 6:30

President Clarence Belitz called the meeting to order. Members present were: David Lorfeld - Vice-President, Deb La Duke - Secretary, Michelle Mauk, Jason Riesterer, and Pastor Patrick Schultz. There were no additions or corrections to the agenda and it was approved. Pastor led the group in prayer.

Motion to approve the Secretary's Report as printed was made by Michelle and seconded by David. Motion carried.

Motion to approve the Treasurer's Report as printed was made by David and seconded by Michelle. Motion carried. Noted was a lower balance in total contributions comparatively with 2019. The OCWM is also at approximately 50% of our yearly goal. All contributions are greatly appreciated.

Pastor's Report: Pastor Schultz has done significant work on the webpage. We are still looking for a volunteer to carry out the updates for St. James. He will be on vacation from November 26-December 6. Speakers have been booked for the two Sundays in his absence. Consistory members will support the remainder of the services. You Tube views have decreased by approximately 50%. Possible explanation is that church has been open and members have been attending. He has received letters of transfer from four families. The speaker for Mission Fest has decided to stay safer at home and will forward Pastor a video of her message to share with the congregation. Discussion has begun regarding Christmas Eve and Christmas services. Considering the current limitations for attendance with Covid, possibilities are being considered. Consistory members were asked to send cards of care to members of the congregation.

Building and Grounds: Brian Herschel will trim the bushes again for us this fall. Thank you! Clarence has been working with Jerry Jetzer to set up a TV in the basement so that we can broadcast the church service in an additional space. This will support the limited numbers we can currently have in the narthex.

Committee Reports:

- Vision of Hope: Motion to approve the two recommendations from the Vision of Hope committee was made by Deb and seconded by David. Motion carried.
- Stewardship Committee: Pastor shared his experiences and ideas regarding stewardship with the committee at their recent meeting. More discussion to follow.
- Christian Board of Education: Students received packets of lessons and activities for the month of October as they practice safer at home. Teachers will reconvene at the end of October to reorganize for November.
- Evaluation process for church and pastor will be discussed at the Joint Consistory meeting on October 19th, Covid protocols continue.
- Michelle has the paperwork to submit for "Adopt a Highway." St. James will be assigned a section of highway to keep clean.

New Business:

- Jason made a motion to set next year's goal for OCWM at \$6,000.00 and David seconded. Motion carried.
- Announcing birthdays and anniversaries will not be done during the service. We will instead look into posting these exciting milestones in another manner at church.
- Adding hymn words to Sunday bulletins will not occur. Singing is not in alignment with the current safety guidelines from the State of Wisconsin and the CDC.
- St. James is in need of a Treasurer. We are also looking for an organist. Both of these are paid positions. Please contact Pastor or a Consistory member if you are interested.
- We reviewed the upcoming events of the Mueller wedding and Mission Fest.
- Church is in need of updates and additions to our present audio/visual equipment. Pastor and speakers do not have opportunity to show video, slides, and computer casts in a professional manner. Weekly information can also be shared. Clarence received a quote from Extreme Sound in Manitowoc and O & W from Sheboygan for A/V equipment and installation. Discussions continue.
- Stewardship meeting November 2 at 6:30P.M.
- Michelle will pick up bulletins each week.
- Review of World Communion Sunday service All went well for our first time using the prepacked wafers and juice.
- No members in the hospital or recuperating currently. Praise the Lord!
- Joint Consistory meeting set for Monday, October 19th at St. James 6:00

Members from St. Mark's were Bruce Mansker – President, Dave Call – Vice-President, Judy Steinbeck – Financial Secretary, Louise Jetzer – Treasurer, Lori Roelse – Secretary, Tara Vandoske, and Jacob Grunwald.

Motion to accept the Secretary's Reports from the October 21, 2019 meeting at St. Mark's came from Deb and seconded by David L. Motion carried.

Business:

—Our churches continue to be able to be open because the recommended Covid protocols have been followed. We will continue to require masks, social distancing, exiting the building as soon as possible, use sanitizer for hands, and monitor the attendance so that it follows state guidelines.

—The 2021 calendar was set. Motion to continue with the "Strengthen the Church" campaign on October 25, 2020 was given by Lori and seconded by Dave C. Motion carried. This offering will go to

our UCC Conference.

—The Thanksgiving Eve worship service will be at St. Mark's and the offering will go to the Salvation Army.

—There has been a change to the Sunday School Christmas programs. Both churches have decided to keep the students safer at home. They are in discussion on having an Easter program instead.

—Motion was made by Deb and seconded by David L. to increase the church Secretary's wage to \$13.00 /hour. Motion carried. It will begin January 2021.

-We continue to look to hire additional organists. We are asking people from Lakeland University and

surrounding areas.

—Karen Mansker our Church's secretary completed research into printing our own bulletins. It would provide a substantial savings and she is willing to add this to her responsibilities. Motion to print our own bulletins was made by Dave C. and seconded by Tom. Motion carried.

—Pastor Schultz provided the Consistories with his annual report summary and compensation package proposal. Presidents of each church will announce a special meeting date and present details to the congregations for discussion and a vote.
